# Policy recommendations

 Harmonization of appropriate laws and policies at the regional and continental level on broodstock bank development and fingerling production.

Africa

- Develop appropriate breeding technology for indigenous species and transfer it to member states for adoption.
- Establish guidelines and standards for producing quality fish seed and development a mechanism for its enforcement (protection of biodiversity).
- Train and advocate/publicize Best Aquaculture Practices (BAP) among non-state actors and other stakeholders in the industry (create more centers of excellence in the regions).
- Subsidize private investments in hatchery operations.
- Development of entreprenuership and promotion of private investment in hatchery operation and broodstock production.
- Increase the visibility of regional hatcheries via e-marketing systems to facilitate trade.







## POLICY BRIEF

#### THE PROMISE OF CAGE AQUACULTURE FOR FOOD SECURITY AND PROFIT: BALANCING GROWTH AND ENVIRONMENTAL CONCERNS

Unlocking the Potential and Sustainably Managing Cage Aquaculture for Food Security and Profit

## RECOMMENDATIONS

- The AU-IBAR should facilitate cooperation between Regional Bodies and Member States for the development of sustainable cages aquaculture.
- 2. Member States should facilitate special interventions to engage the private sector and financial institutions in cage aquaculture development and investment.
- 3. African regional fisheries and catchment bodies should facilitate the harmonization of policies and legislation governing cage aquaculture.
- Encourage research by Centers of Excellence (CoEs) into feed, seed, and integration of complementary aquaculture species, (for example, aquatic plants) to reduce the environmental nutrient load from cage aquaculture.
- 5. Member States should encourage cage aquaculture skills capacity building initiatives including short courses, on-farm internships and on-the-job mentorship.







1. AU-IBAR coordinate with Egypt to provide the technology know how to the Member State by; -

- Covering on-the-job training cost for farmer in Egyptian farm.
- Select Member states and install the pilot project in at least 3 countries with the cooperation of Egyptian experts, Egyptian institutions and practical training centres.

2. AU-IBAR coordinates with Member states to create awareness meeting for private sector to transfer the Egyptian success story to their Countries.

3. Member States to include in their strategy the Agri-Aquaculture system to produce the feed raw material for self-sufficient from animal feed.

4. Member States should encourage the investors by delivering some incentives for Agri-Aquaculture system to reduce the cost of fish production and produce the natural resources and for smart climate system.

5. The integrated Aquaculture system can be used as a way of life in various forms of fish farming, whether in fresh water - salt water - fish ponds - fish cages, in order to reduce the cost of production so that the cost of production is distributed over multiple types of outputs to achieve food security in the African continent
