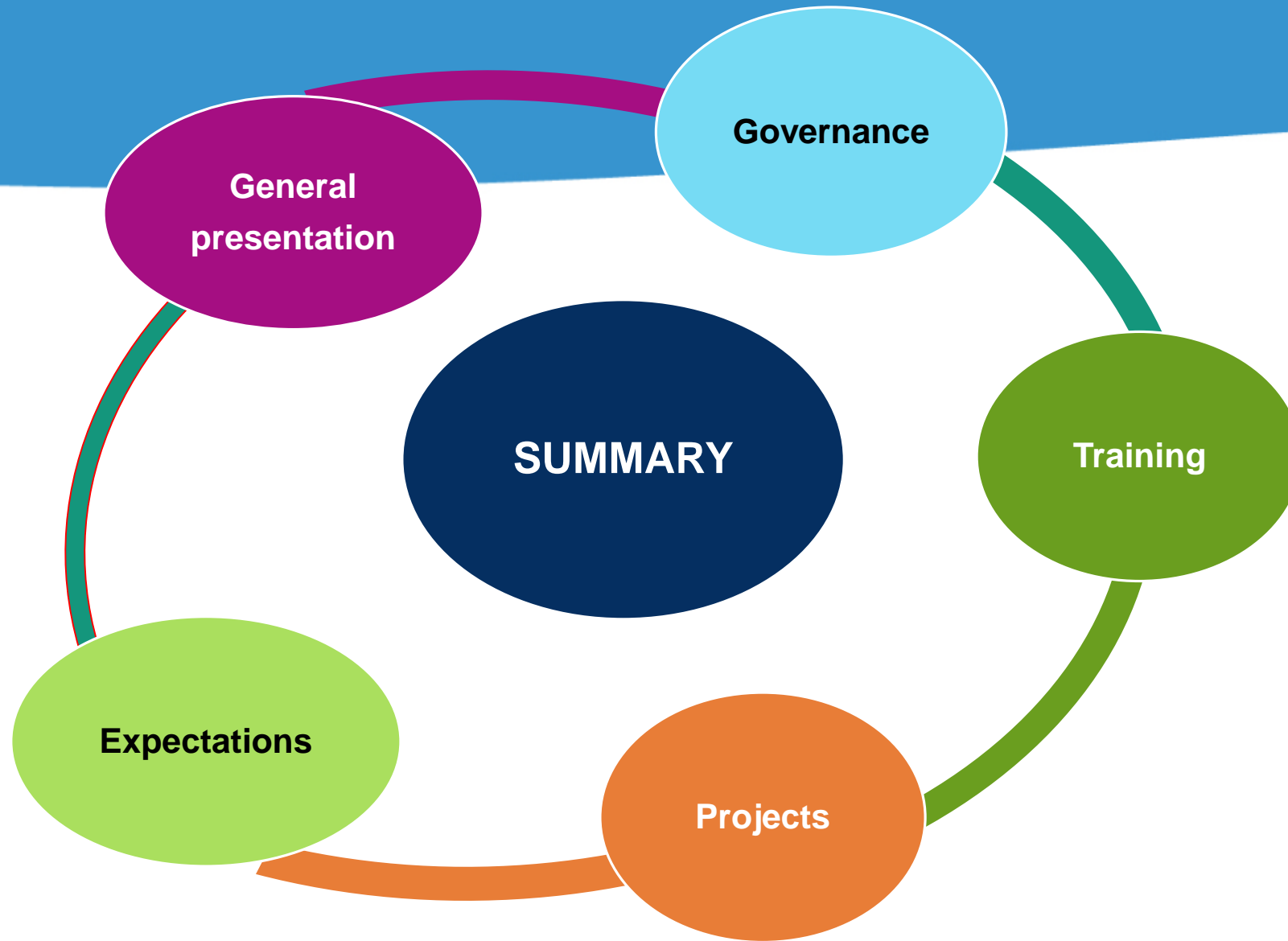

The Regional Academy of Marine Sciences and Technologies (ARSTM) is the **regional institution of maritime, port and industrial training of the 15 french-speaking countries of West and Central Africa.**

ARSTM was built by Côte d'Ivoire with the support of its partners for a cost of about 30 million dollars (16 billion FCFA).

It's opened since 1987 and covers an area of thirty three (33) hectares. It has a diplomatic status.

L'ARSTM comprises:
02 Colleges (ESTM / ESN),

01 Centre of Maritime Education and Training (CEAM),

01 Institute for human-resources capacity building (ISMI) and

01 Centre of Research (CREMPOL).

ESTM

Offers courses for shore-based personnel of maritime transport auxiliary companies for forwarding agents, stevedores...

ESN

Specialized in the training of Deck and seagoing personnel (senior officers), Deck and Engine petty officers of the merchant navy and senior technicians in industrial maintenance.

CEAM

Trains junior Deck and Engine seagoing officers, **fishery skippers and crew of merchant and fishing fleet.**

ISMI

In charge of the capacity-building of personnel, ports and other entities with offshore skills with the purpose of fighting all illicit acts of maritime insecurity in the Gulf of Guinea. It's been created in october 2015 with the support of France.

CREMPOL

Its mission is to bring pragmatic solutions to the logistical challenges faced by African States, in particular, transport offers, port passages and corridor management. CREMPOL deals also with issues related to fishing, maritime safety and security,

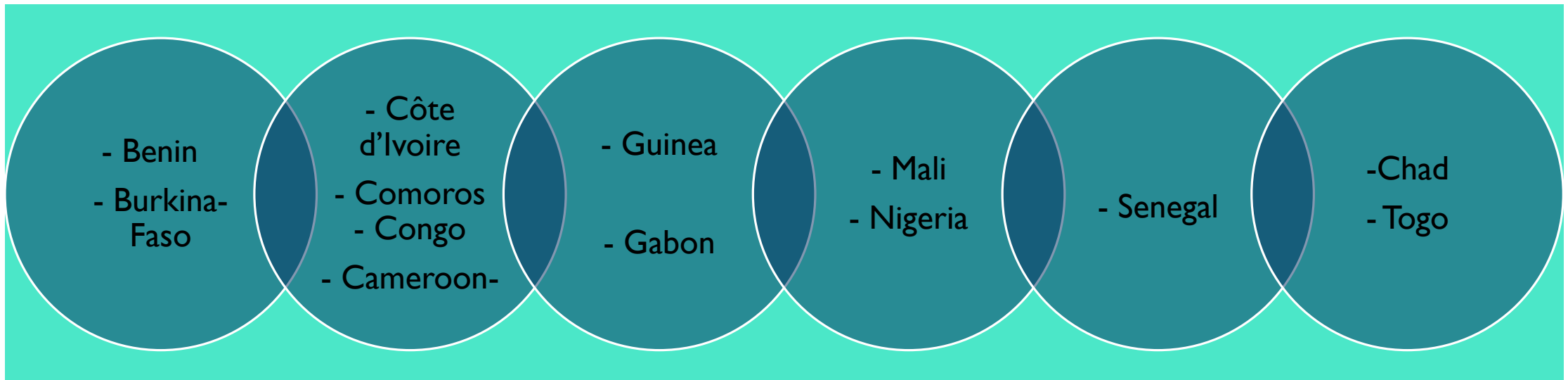

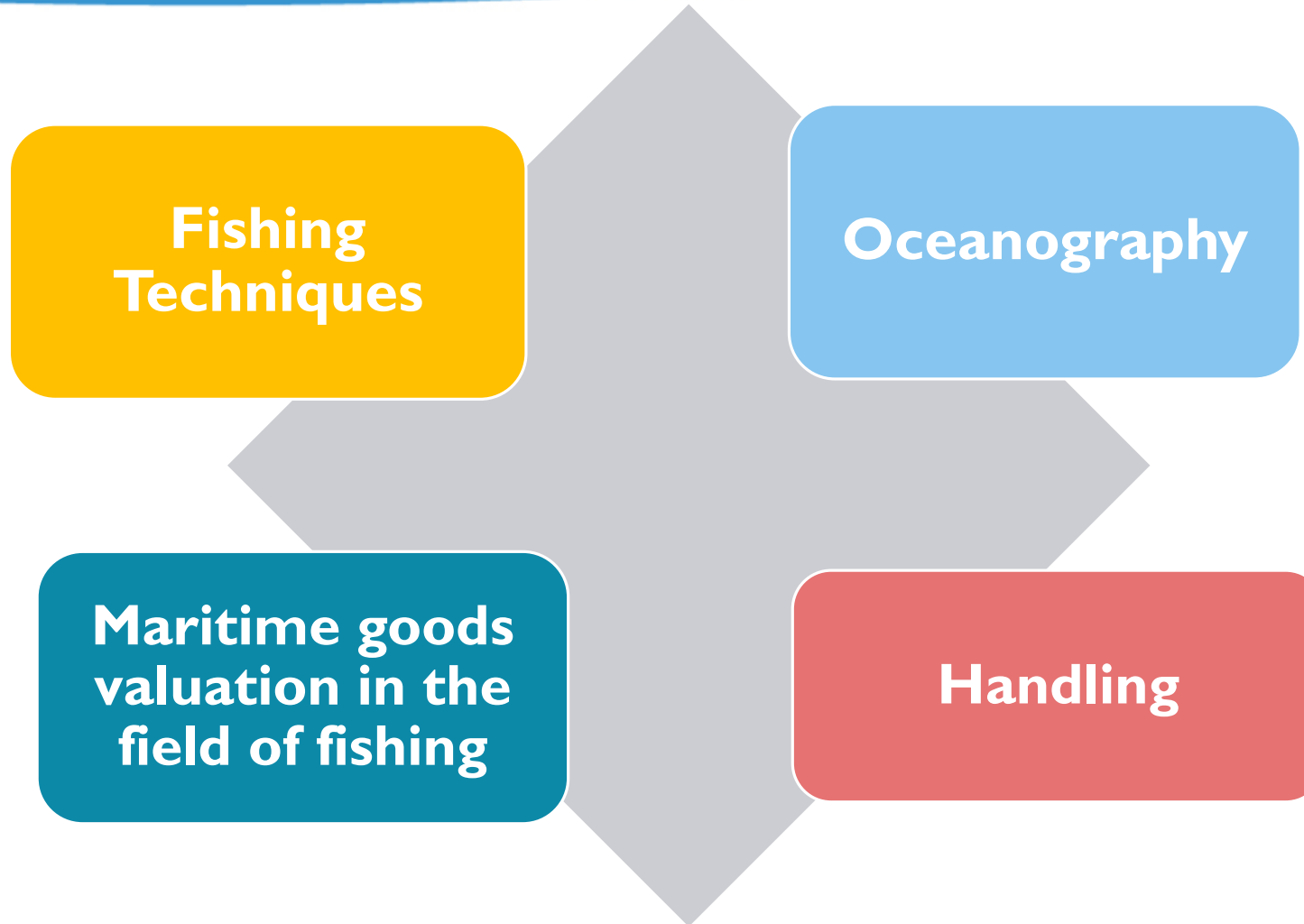

THE INTERREGIONAL MARITIME SECURITY INSTITUTE (ISMI)

GENERAL PURPOSE

ISMI was created in application of the resolutions of Yaoundé Summit on Maritime Safety and Security and the National Strategy of the States Action at Sea.

Opened in 2015, ISMI's main objective is :

Capacity-building of personnel of the Administrations, Ports and other entities involved in the States Action at Sea in other to :

- Preparing them to develop strategies;
- Bringing them to conduct missions against all acts maritime insecurity (Piracy, Armed-robbery, cybercriminality etc.

From 2016 to 2022, the ISMI organized 10 training sessions in the field of the fight against IUU-FISHING.

- ▶ - 7 training sessions on fisheries inspection for fisheries inspectors in West and Central Africa financed by French Cooperation, including 1 per year;
- ▶ - 1 train-the-trainer session for fisheries inspectors financed by the CPCO (Sept. 2019);
- ▶ - 3 training sessions organized within the framework of the PESCO program of the European Union and carried out by the European Fisheries Control Agency (Fisheries Inspection, Operators of Fisheries Surveillance Centers (Nov. 2019), Fisheries Inspection for Ivory Coast (March 2022).
